- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue no. **February 5, 2009**
- 2. The Government of Montenegro has received a loan in the amount of EUR 11 million (US\$15.7) equivalent from the International Bank for Reconstruction Development (IBRD) and from the Global Environment Facility Trust Fund, GEF, in the amount of US\$ 4 million toward the cost of the Montenegro Institutional Development and Agricultural Strengthening Project (MIDAS) and it intends to apply part of the proceeds to payments under the Contract for **Procurement of Vehicles for Ministry of Agriculture and Rural Development and Extension and Advisory services**
- 3. The Ministry of Finance-Technical Service Unit now invites sealed bids from eligible and qualified bidders for Procurement of:

Lot 1 Economic class vehicles – six pieces;

Lot 2 Four wheel drive vehicles –two pieces.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, edition May 2004, revised October 2006 and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

- 5. Interested eligible bidders may obtain further information from **Technical Service Unit** and inspect the Bidding Documents at the address given below from **9.00 h 17.00 h local time, on working days**.
- 6. Qualifications requirements include:
 - Proof of legal status and place of registration;
 - Letter of recommendation or other document which proves that the Bidder have been successfully completed **at least two** contract as a prime supplier involving delivery of equipment of similar technical characteristics and of a comparable scale in the **last three years** (2011, 2010, 2009)
 - If an Agent submits bids on behalf of more than one Manufacturer, each bid should be accompanied by a separate Bid Form, Bid Security for each bid and the authorization from the respective Manufacturer.
 - Manufacturer's Authorization if Bidder is not a manufacturer;
 - Statement confirming after sales service in Montenegro
 - Joint Venture (JV):
 - If the Bidder is a Joint Venture of two of more partners, the information listed above shall be provided for each partner. This is applicable to Joint Venture partners only, not to subcontractors. The partners of the Joint Venture add together their contributions to meet the qualification requirements listed above.
 - Bids submitted by a JV of two or more firms as partners shall comply with the following requirements:
 - (i) the bid shall be signed so as to be legally binding on all partners;
 - (ii) one of the partners shall be nominated as being in charge, and this nomination shall be evidenced by submitting a power of attorney signed by legally authorized signatories of all the partners;
 - (iii) the partner in charge shall be authorized to incur liabilities and receive instructions for and on behalf of any and all partners of the Joint Venture, and the entire execution of the Contract, including payment, shall be done exclusively with the partner in charge;
 - (iv) all partners of the Joint Venture shall be liable jointly and severally for the execution of the Contract in accordance with the Contract terms, and a statement to this effect shall be included in the authorization mentioned under (ii) above, in the bid as well as in the Contract (in case of a successful bid).
 - Statement confirming after sales services in Montenegro.
