Amendment

In Section II -- Bid Data Sheet (BDS):

1. Clause ITB 21.1 has been changed and shall now read:

ITB 21.1	<p>It is allowed that Bidder submit original Bid (via some post express service or similar), or copy of the Bid, until the established deadline for submission of the Bid, June 16, 2020, 10.00h.</p> <p>In case that Bidder decides to submit Bid as a copy, third party (in-country representative of the Bidder) must print the Bid and deliver copy of the Bid on the address for delivery of Bids, within established deadline for submission of Bids. The representative could be a business partner, diplomatic mission or a print store that couriers the Bid upon a written authorization by the bidder. Printed copy of this Bid should be accompanied with one copy in electronic media, such us DVD, flash drive, or similar.</p> <p>Bidder who submits the Bid as a copy, through in-country representative, will be obliged to send at the address for delivery of Bids also original Bid, including original Bid security and Bidding Forms (such as Letter of Bid, Price schedule forms, etc) and entire original Bid. Original Bid must be mailed until established deadline for submission of the Bid, June 16, 2020, 10.00h, and Bidder is obliged to submit a proof (as a stamp with the date of dispatch issued by the courier) that original Bid has been submitted to them within established deadline.</p> <p>In case that Bid is submitted as a copy, through in-country representative, the copy of the Bid must be identical to the original Bid which will be received later and it is not allowed any discrepancy between copy of the Bid submitted through in-country representative, and original Bid.</p> <p>In addition to the original of the Bid, the number of copies is: two (one original and one printed copy and one copy in electronic media, such us DVD, flash drive, or similar)</p>
